

## Rates Safety Culture Ladder 2020

Version 2, 2020-04-22

The Safety Culture Ladder is a market initiative. The principle of the certification scheme is that all companies and organizations involved, jointly finance the scheme and contribute proportionately to the costs of the ladder. This way, the helpdesk, the management of the certification scheme, the register of certificates, the website, the administration, the further development, quality control and the supporting of initiatives are financed. Use of the Safety Culture Ladder should consequently generate sufficient income to ensure that the scheme remains up-to-date and applicable in the future.

The rates (excluding VAT) as indicated below are relevant for the audited organizations and are effective from 22 April 2020.

### License fee for certification bodies

Certification bodies (CBs) that have a license agreement with NEN, have to pay a fee per year. The amount of the fee is € 2.040,00 per year.

### Certification fee for SCL Original, SCL and SCL Light

A certification fee applies for:

- the initial certification and the re-certification per year for SCL Original;
- the initial and follow-up audits for SCL;
- the initial statement for SCL Light.

The certification fee is based on the size of the audit in man-days, following the table below. The certification fees are charged quarterly to the certification bodies based on the audits performed.

### **Fee for Approved Self-Assessment and 'Check on action plan'**

In the following situations, a fee is charged depending on the size of the company with respect to the amount of employees:

- per year for the Approved Self-Assessment, for the initial audit as well as for the check on action plan in year 2 and 3;
- For the check on action plan for SCL Light in year 2 and 3

Up to and including 25 employees: Euro 50,00

More than 25 employees: Euro 100,00

### **Contribution of LCI's for authorization of auditors and the witness audit**

Costs for the authorization of auditors and for the witness audits will be charged to the CBs. The amounts are:

<b>Contribution LCI for the authorization of an auditor</b>	€ 295,00
<b>Contribution LCI per witness audit</b>	€ 1.775,00

### **Succession of incidents**

The following costs for planning and extra witness audits or the assessing, confirming and monitoring of dispensation in regard to the requirements will be charged:

<b>Additional witness audit (per audit of 4 hours)</b>	€ 888,00
<b>Dispensation and monitoring (per auditor)</b>	€ 592,00

### **Validity and indexation of rates**

All rates stated in this document, are valid in 2020 and will be indexed per year.
